Subj.: The amendment of the tender conditions No.2

According to the public contract in the above-limit supply regime entitled: " LF/UMTM - Restoration of a confocal microscopy device integrated into a robotic platform ", awarded in an open procedure, published in VVZ under evid. No .. Z2020-039256, in accordance with Act No. 134/2016 Coll., on the award of public contracts, as amended, we inform you of the following amendment of the tender documentation:

Question 1:

The requirement for the 40X Water Immersion objective is NA=1.1. We supply the 40X Water Immersion objective with NA=1.0. Can this be accepted?

Answer:

The contracting authority states that the intention was to set the value of this parameter to NA = 1.0 from the beginning.

Therefore, in Article 2.2.1 in the Czech version of the tender documentation, this parameter is stated correctly:

- Objektiv s vodní imerzí pro fluorescenci se zvětšením 40x (přípustná tolerance zvětšení objektivu je +-20%), s minimální NA=1 (**parametr NA - hodnotící parametr**)

The Contracting Authority hereby harmonizes the other parts of the tender documentation as follows:

a) In Article 10 (Rules for the evaluation of tenders) of the Czech version of the tender documentation, the following text for point No. 15 is replaced in the table of sub-criteria No. 2:

With this text:

Objektiv pro fluorescenci využívající vodní imerzi se zvětšením 40x (+-20%), s minimální NA=1.0, přičemž hodnota NA bude bodově hodnocena.

b) In the English version of the tender documentation

BA) In Article 2.2.1 the following text is replaced:

- Objective lenses optimized for fluorescence 40x (permissible lens magnification tolerance is + -20 %) with minimum NA=1.1 water immersion (**evaluation parameter**)

With this text:

- Objective lenses optimized for fluorescence 40x (permissible lens magnification tolerance is + -20 %) with minimum NA=1.0 water immersion (**evaluation parameter**)

BB) In Article 10 (Rules for the evaluation of tenders), the following text for point No. 15 is replaced in the table of sub-criteria No. 2:

Objective lenses optimized for fluorescence 40x (+-20 %)with minimum NA=1.1 water immersion, NA value will be evaluated

With this text:

Objective lenses optimized for fluorescence 40x (+-20 %)with minimum NA=1.0 water immersion, NA value will be evaluated

The other conditions remain unchanged.
