**Subj.: The explanation and the amendment of the the tender conditions No.1**

According to the public contract entitled: " Three-dimensional linear ion trap ", we inform you of the following explanation and amendment of the tender documentation:

**Question 1:**

1) re section 2. Warranty and service

The contractor shall provide warranty for quality performance, which may not be less than 12 months.

During the guaranty period, the respective defects shall be removed within 30 calendar days [t1] at the latest after the day of the defect notification (by email, letter form, fax), unless otherwise agreed in writing by persons authorized by contracting parties for technical matters.

Seller is obliged to remove the defects in the place of delivery. [t2] Shall that be evidently technically impossible, the seller upon the agreeing the suggested procedure, signs the protocol together with the person authorized in technical matters for the buyer, shall take over the defective part of the goods for repair.

The following points are from AQT:

[t1] - Depending on the error (say, broken sapphire frame), 30 days may be too short. Can we increase this?

[t2] - We can't repair the trap in Olomouc. It will have to be returned, even if it's 'just' cleaning.

If an alternative wording exists, please do submit to us for further consideration.



**Answer:**

The Contracting Authority hereby replaces the following requirement in Article 2. of the tender documentation:

During the guaranty period, the respective defects shall be removed within 30 calendar days at the latest after the day of the defect notification (by email, letter form, fax), unless otherwise agreed in writing by persons authorized by contracting parties for technical matters.

Seller is obliged to remove the defects in the place of delivery. Shall that be evidently technically impossible, the seller upon the agreeing the suggested procedure, signs the protocol together with the person authorized in technical matters for the buyer, shall take over the defective part of the goods for repair.

**With this text:**

During the guaranty period, the respective defects shall be removed within 60 calendar days at the latest after the day of the defect notification (by email, letter form, fax), unless otherwise agreed in writing by persons authorized by contracting parties for technical matters.

The seller upon the agreeing the suggested procedure, signs the protocol together with the person authorized in technical matters for the buyer, shall take over the defective part of the goods for repair.

**Question 2:**

2) Demonstration of qualification

Is the business licence, which has been checked and provided by the Austrian chamber of commerce, sufficient?

**Answer:**

Yes, this document is sufficient.



The other conditions remain unchanged. In the appendix to this amendment is a new draft of the purchase contract, where the changes are recorded.
