The Contracting Authority will assign the following weights to the individual evaluation sub-criteria as percentages according to their importance for the tender proceedings in such a way so that the sum of said criteria percentages amounts to 100. The Contracting Authority has designated the following evaluation sub-criteria for the evaluation of the bids:

the amount of the bid price without VAT **weight: 60 %**

the technical parameters **weight: 40 %**

In accordance with Section 122 (2) of the Act, the Contracting Authority **did not evaluate tenders**, because there was only one participant in the procurement procedure.

Due to the nature of the matter and to ensure full functionality and compatibility, it is therefore not possible to divide the public contract into more than four lots.
