SUBJECT-MATTER OF THE PUBLIC CONTRACT

The subject of the 3rd part of the public contract is the supply of a vacuum shut-off valve including accessories. The detailed technical specification is set out below in Article 2(2.2) of this Documentation. The system will be used for the study of the interaction between light and matter and molecular spectroscopy. The vacuum pumps will be used to create and maintain a vacuum in a radio frequency trap chamber designed to simultaneously trap atomic and molecular ions and implement protocols using quantum logic with applications in molecular spectroscopy.

The molecular ion will serve as the spectroscopic ion whose spectrum will be investigated, and the atomic ion will be used for laser cooling and to read the spectroscopic information. The ions will be coupled to each other via near ground state modes of motion.

For this type of research, it is crucial to achieve ultra-high vacuum or extremely high vacuum to isolate the trapped ions from the effects of collisions with other elements that make it difficult to trap the ions themselves, shorten the trapping time, and prevent coherent preparation and study of ion motion.

The contracting authority has excluded the tenderer Activair s.r.o., with registered office at Hillova 1562/15a, 747 05 Opava - Kateřinky, ID No.: 28605837 (hereinafter referred to as "the Participant") from the tender procedure for the 3rd part of the above-mentioned public contract.

Justification:

Pursuant to Article 2, paragraph 2.1 of the tender documentation, the supplier is obliged to comply with the technical requirements set out in the tender documentation, if it fails to comply with them, it will be excluded from the tender procedure pursuant to Section 48, paragraph 2, letter a) of the Act.

The contracting authority required, inter alia, in Article 2(2.2) of the tender documentation to comply with:

Vacuum valve - 1 vacuum shut-off valve with the following parameters

- be sinterable to more than 250 °C.

In the Bidder's Bid, the Bidder does not indicate whether the vacuum valve offered by the Bidder meets this technical parameter.

On 25.02.2025, the Committee appointed by the Authority, also for the purpose of assessing compliance with the conditions of participation in the tender procedure, requested the Bidder to clarify/add to the specific model of the vacuum isolation valve offered by the Bidder in its bid, including its technical parameters to verify compliance with the technical requirements required by the Authority, and also how much °C the offered vacuum isolation valve is sinterable up to. The deadline for clarification/completion of the above has been fixed till 06.03.2025.

On 06.03.2025 the Participant informed the Contracting Authority that it "cannot confirm the required temperature".

On 06.03.2025, the Commission found that the Participant failed to prove compliance with the tender conditions within the time limit set pursuant to a request under Section 46 of the Act.

Therefore, on the basis of the above facts, the Contracting Authority excluded the Participant from the procurement procedure of the above-mentioned public contract in accordance with Section 48(2)(a) of the Act, as the Participant failed to prove compliance with the terms of reference within the time limit set in response to a request under Section 46 of the Act.

In accordance with procurement conditions the purchase contract was concluded with the above-mentioned selected economic operator on the 03.04.2025.

REASONS FOR SELECTION OF THE ECONOMIC OPERATOR:

The evaluation of tenders for the 1st part of the public contract was carried out in accordance with Section 114(1) of the Act according to their economic advantage. In accordance with Section 114(2) of the Act, the economic advantage of the tenders was evaluated according to the lowest tender price.

The evaluation was carried out according to the absolute amount of the total tender price in CZK excluding VAT for the entire subject of the public contract. The tenders were ranked in order from the lowest to the highest tender price. The lowest tender price in CZK, excluding VAT, was the best evaluated.

The tenders of the suppliers who were not excluded from the tender procedure were evaluated by the committee and the following ranking was established. The tender of the supplier with the lowest tender price was ranked 1st and the tender with the highest tender price was ranked last.

The tenderer Activair s.r.o., with registered office at Hillova 1562/15a, 747 05 Opava - Kateřinky, ID No.: 28605837, was excluded from the tender procedure for the 3rd part of the public contract pursuant to Section 48(2)(a) of the Act.

The tender of the selected economic operator met all the requirements of the Contracting Authority stated in the procurement conditions.
