The Contracting Authority shall exercise its right in accordance with the provision of Section 141(5) of the Act, on the basis of which the Contracting Authority is entitled, in the case of public contracts awarded in a dynamic purchasing system, to conclude a contract with the selected supplier before the expiry of the deadline for submitting objections to the selection of the supplier. In this case, Section 246 of the Act shall not apply.
