# SUBJECT-MATTER OF THE PUBLIC CONTRACT

The subject of the public contract is the upgrade of a robotic platform from HighRes Biosolutions Inc. (inv. No. 3207114), which has been owned by the Contracting Authority since 2014 and is operational at the Institute of Molecular and Translational Medicine of the Faculty of Medicine and Dentistry, Palacký University in Olomouc, including installation and training of qualified personnel and warranty service. The Contracting Authority also requires the performance tests and validation of the entire system as part of the installation of the equipment to ensure the full functionality of the new assembly.

# **REASONS FOR SELECTION OF THE ECONOMIC OPERATOR:**

The evaluation criterion of economic advantage was the lowest tender price.

In accordance with Section 122(2) of the Act, the Contracting Authority did not evaluate tenders, because there was only one participant in the procurement procedure.

Within the limits set by the Act and the facts of the case, the Contracting Authority intends to use the negotiated procedure without prior publication within the meaning of Section 63(3)(b) and (c) and pursuant to Section 67(1) of the Act for the purpose of awarding this public contract, as the **Invited Supplier named below is the exclusive supplier of the robotic platform HighRes Biosolutions**. Exclusively the below requested components from the manufacturer HighRes Biosolutions Inc. are compatible with the existing robotic platform HighRes Biosolutions, which is owned by the Contracting Authority and installed at the Institute of Molecular and Translational Medicine, Faculty of Medicine and Dentistry, Palacký



University in Olomouc (year of acquisition 2014, inv. No. 3207114) and whose upgrade is required by the Contracting Authority.

The procedure of the Contracting Authority to carry out the public contract in question in the mode of the negotiated procedure without prior publication is the only possible one, taking into account the obligation to fulfil the duties of a sound economic manager, as well as to dispose of all assets conscientiously and, last but not least, it is considered to be in line with the 3E principles. Furthermore, the Contracting Authority notes that for technical reasons and in the context of exclusivity, it is not possible to address or involve more than one supplier in the procurement procedure, and the procedure by means of a negotiated procedure without prior publication on the basis of the provisions of Article 63(3)(b) and (c) of the Act is therefore the only possible one.

Section 217 (2) i) of the Act justification of the use of a light regime, where such regime was used

A light regime was not used.

Section 217 (2) j) of the Act justification of the procurement procedure where such cases occurred

The procurement procedure was not canceled.

Section 217 (2) k) of the Act justification of the use of means of communication other than electronic means for the submission of tenders, where such other means were used

Tender was submitted only electronically.

The public contract is not divided into parts, as the subject of the public contract can be delivered only by one supplier, the division of the public contract into parts is therefore completely meaningless and would not mean any benefits for the Contracting Authority under this public contract, and there will be no discriminatory behavior.
