In accordance with the terms of the tender, the purchase agreement was concluded with the above-mentioned selected economic operator on the 10<sup>th</sup> November 2025.

#### **REASONS FOR SELECTION OF THE ECONOMIC OPERATOR:**

The commission proceeded to the evaluation of the tenders in accordance with the procedure set out in the procurement conditions.

In accordance with Section 114(1) of the Act, tenders were evaluated based on their economic advantage.

In accordance with Section 114(2) of the Act, the economic advantage of tenders was evaluated based on the lowest tender price.

The evaluation was carried out according to the absolute total tender price in EUR without VAT for the entire subject matter of the public contract. The tenders were ranked in order from the lowest to the highest tender price. The lowest tender price in EUR without VAT was evaluated as the best.

The commission evaluated the tenders of suppliers who were not excluded from the tender procedure and determined the following ranking.

The tender with the lowest tender price was ranked first, and the tender with the highest tender price was ranked last.

The public contract is not divided into the parts, as the subject of the public contract forms a compact unit with accessories, where it is not technically possible to divide the public contract. Due to the nature of the matter and to ensure full functionality and compatibility, it is therefore not possible to divide the public contract into parts. It is a highly sophisticated unit, where it is not possible to separate individual components.
